**§ 93.02 AUTHORITY.**

ORS Chapter 215 and Chapter 92 empowers the County Board of Commissioners, hereinafter, the Board, to define through an ordinance the procedures and requirements relating to the addressing of dwellings in the unincorporated areas of the county; and to provide a uniform road naming system for the county.

**§ 93.03 PURPOSE.**

(A) To establish and enforce a permanent, systematic and county-wide rural address and road naming system. Such a system is necessary for the protection of health, safety and welfare of the residents of the county. A systematic addressing plan will facilitate the location by emergency services and others, of dwellings, businesses, and other buildings of interest and importance by a site address and identifiable road name. The provisions of this chapter will serve to eliminate the problems and confusion associated with the continually changing rural route and box system.

(B) Naming or renaming private lanes or public roads not currently in the County Road Department's maintenance system, shall not mean the county accepts or will maintain these roads or lanes.

**§ 93.04 AREAS EXEMPT FROM PROVISIONS.**

This chapter does not pertain to the following areas within the county: inside incorporated city limits and their associated urban growth boundaries, or other areas deemed necessary and appropriate by the Board.

**GENERAL PROVISIONS**

**§ 93.01 TITLE.**

**§ 93.05 DEFINITIONS.**

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

**ACCESS POINT/DRIVEWAY POINT.** Where the primary driveway enters the road on which a building is addressed.

**ADDRESS.** An address shall consist of a five digit number and a road name. This address shall be determined at the location where the primary access driveway intersects a county road, public road, or private lane.

**BOARD.** The County Board of Commissioners.

**BUILDING.** A building designed for human occupancy, such as a residence or place of business, or other buildings, as determined by the Planning Department.

**COUNTY ROAD.** A public road under the jurisdiction of a county that has been designated as a county road under ORS 368.016.

**EAST/WEST ROAD.** A road that runs predominately east and west. Roads that lie predominately at an angle less than 45° from due east or due west shall be numbered as east/west roads, except as otherwise provided.

**NORTH/SOUTH ROAD.** A road that runs predominately north and south. Roads that lie predominantly at an angle less than 45° from due north or due south shall be numbered as north/south roads, except as otherwise provided.

**PLANNING DEPARTMENT.** The Umatilla County Planning Department.

**POSTAL DELIVERY AREA.** The area in which mail is delivered from a single post office.

**PRIVATE LANE.** A private right-of-way created by recorded easement, or other instrument, or an existing lane used for access, where no recording has taken place, or no right of interest has accrued to the public. In either case, the lane has not been dedicated to, or accepted by the county, or other public body, and has not been designated as part of the county road maintenance system.

**PUBLIC ROAD.** A road over which the public has a right of use that is a matter of public record. **PUBLIC ROADS** are also known as **LOCAL ACCESS ROADS** under ORS 368.001(3) and 368.031. The county has jurisdiction over local access roads and public roads, but not maintenance responsibilities for them.

**RURAL ADDRESS COMMITTEE.** The 12 member citizen group appointed by the Board on November 6, 1991. The Committee is advisory to the Board in rural address matters, which include, but are not limited to, establishing rules; resolving conflicts; making recommendations; forming and presiding over the Satellite Committees.

**RURAL ADDRESS SYSTEM.** A system using the Oregon State Plane Coordinates System, which has been established by the National Geodetic Survey of the National Ocean Service for defining and stating the positions on points on the surface of the earth within the State of Oregon. The county is included in the “north zone” of the Coordinate System as established on June 16, 1945 and described in ORS 93.320(3).

**SATELLITE COMMITTEE.** Citizens recruited by respective area Rural Address Committee members to assist them in formulating recommendations regarding naming and renaming roads. Members of the Satellite Committees shall be residents of the county. (Ord. 92-03, passed 5-20-92)

**ROAD NAMING**

**§ 93.15 PURPOSE AND INTENT.**

The procedures set forth herein are for the purpose of establishing a uniform policy in the county for the naming and renaming of existing and future roads. It is intended that this policy will clarify and set the requirements and responsibilities of individuals, public bodies, and departments involved in the naming and renaming of roads. In addition, it provides the public with an outline of the required process for road naming and renaming. (Ord. 92-03, passed 5-20-92)

**§ 93.16 ROAD NAMING.**

(A) Roads shall be reviewed and named by the Planning Department, subject to the approval of the Board.

(B) The following situations will require approval of the Board of Commissioners, subject to the Planning Department's naming action pursuant to § 93.19

(1) When any unimproved county road or public road is constructed and used as a road;

(2) When any county or public road is established, including when these new county or public roads will have names established within the provisions of the County Zoning, Partition and Subdivision Ordinance, or in the provisions for establishing a public way as provided by ORS Chapter 368;

(3) When any private lane has the third building accessed from said lane;

(4) When there is a petition to rename an officially adopted road name pursuant to this chapter;

(5) When an application to name a private lane with two or less buildings is approved;

(C) For applications for situations under (3), (4), and (5), applicant(s) agree to pay for installation, maintenance and replacement cost of road sign(s). Addresses shall be changed to reflect access point locations along the named lane or road. Address changes shall be made according to §§93.42 and 93.43 of this chapter. The applicant(s) shall pay for such changed addresses according to this chapter.

(D) All signs shall comply with the requirements of Umatilla County Code of Ordinances Chapter 70. Placement of signs must be approved by the Public Works Department.

(E) Reasons for the naming of roads or lanes include, but are not limited to: (1) Public safety; (2) Assistance of the traveling public; (3) Conflict with public safety.

(F) In the case where a road extends across or straddles county and/or state lines, keeping a single road name will be at the agreement of those

jurisdictions involved.

**§ 93.17 APPLICATION TO NAME OR RENAME ROAD.**

(A) A request to name or rename a road shall be submitted to the Planning Department. An application to name or rename a road shall be submitted and include, at a minimum, the following:

(1) Name and phone number of designated contact person or designated applicant(s);

(2) Location of roadway by description and map;

(3) Legal status of road, if known;

(4) Existing road name, if the request is a renaming proposal;

(5) Proposed road name;

(6) Reason for request;

(7) Fee, if any, as established by the Board;

(8) Signatures of more than 51% of the residents along the road.

(B) An application shall be submitted by an adjacent property owner(s) or person(s) living along the road. Also, the Board, Planning Commission, Planning Department, or other public, or semi-public agencies, which may be impacted by road names may submit an application. Such agencies include, but are not limited to, the following:

(1) Public Works Department;

(2) Assessor or Tax Collector;

(3) Sheriff;

(4) Surveyor;

(5) Cities;

(6) Utility companies;

(7) Board of Trustees, Confederated Tribes of the Umatilla Indian Reservation;

(8) Federal and State Forest Service.

(C) The Planning Department may refer a name or renaming request to the Board if in the opinion of the Planning Department the request involves a policy or ordinance interpretation, or will have a significant impact on a wide area, or is of a controversial nature. (Ord. 92-03, passed 5-20-92; Ord. 92-03A, passed 4-19-95; Ord. 2017-07, passed 5-22-2017)

**§ 93.18 FEE.**

(A) An appropriate fee will be charged depending on the type of application. Such fee as established by the Board may include the cost of construction, installation, and number of signs required, and other costs relating to mailing, public notification, and staff time.

(B) The fee, if applicable, will be paid at the time of application submittal.

(C) An application submitted by another county department shall not be charged a fee. (Ord. 92-03, passed 5-20-92; Ord. 2017-07, passed 5-22-2017)

**§ 93.19 PLANNING DEPARTMENT REVIEW OF APPLICATIONS.**

(A) The Planning Department shall have the responsibility for processing and maintaining applications for road naming and renaming.

(B) The Planning Department shall perform such functions in the following manner:

(1) Verify legal status, i.e., ownership and maintenance of road;

(2) Check proposed road name(s), and designation(s), to avoid duplication or similarity with other existing road names and with those preliminarily approved, but not yet recorded partitions and

subdivisions;

(3) Determine if road name change will involve address reassignment(s).

(4) Perform a field check, when necessary;

(5) Assist applicant(s) or other affected person(s) to find alternate names when required;

(6) Notify appropriate departments and agencies if they are affected by the road, i.e., name change. The following list is not all inclusive:

(a) Assessor's Office;

(b) County Records/Elections;

(c) Affected cities;

(d) County Surveyor/County Road Department;

(7) Notify appropriate owner(s), occupant(s), agencies, per § 93.21 of this chapter;

(8) Review and consider all comments submitted;

(9) Assign a road name in accordance with § 93.20 of this chapter. (Ord. 92-03, passed 5-20-92; Ord. 2017-07, passed 5-22-2017)

**§ 93.20 ROAD NAMING STANDARDS.**

(A) *General.* The proposed road name shall:

(1) Not duplicate existing road names, except for continuations of existing roads;

(2) Be limited to 15 characters;

(3) Not sound or spelled similar to other roads as to be confusing;

(4) Not use prefix or directional guides such as "N," "S," "E," "W," as part of the road name, unless deemed necessary;

(5) Conform to the following designation:

<i>Type</i>	<i>Designation</i>
State Roads	Highway
County/Public	Road
Platted Subdivision	Street, Avenue, Court, Way
Easement/Private	Lane

(6) Improve or clarify the identification of an area;

(7) Not reflect surnames unless for reasons of historical value;

(8) Reflect a consensus of sentiment of affected owner(s) and occupant(s), when possible, subject to other standards contained in this division.

(B) *Specific.* When an existing road name is requested to be renamed the following considerations shall be determined in order to approve the proposed new name:

(1) The existing road was named inconsistent with naming standards set forth in this chapter;

(2) The existing name is found to be different than the commonly used name of the road;

(3) The proposed replacement name would better locate or identify buildings;

(4) The road is really an extension or continuation of another road with a different name. (Ord. 92-03, passed 5-20-92; Ord. 2017-07, passed 5-22-2017)

**§ 93.21 APPLICATION NOTIFICATION.**

(A) Notice of a proposed name assignment shall be sent to all person(s) owning property abutting the affected road. Such notice shall be sent within 14 days of the receipt of an application.

(B) If an address reassignment is involved in a name change request, the reassigned addresses shall also be included in the notification in division (A) of

this section, and may be sent to the appropriate agencies in division (C) of this section.

(C) Copies of the order and any related maps approving the naming or renaming of a road shall be sent to the following, and to other appropriate entities, as deemed necessary:

- (1) Public Works Department;
- (2) Assessor's Office and Tax Office;
- (3) Post Office;
- (4) Planning Department;
- (5) County Records Office;
- (6) Sheriff's Office; affected Fire Departments and Emergency Services;
- (7) Affected Cities.

(D) Person(s) receiving notice in division (A) of this section, shall promptly notify any tenant(s) or other occupant(s) of the affected property of the proposed name assignment.

(E) Any person receiving notice in division (A) of this section, may comment in writing if they feel they have information that should be considered in the adoption of the name. Any such comments shall be made within 14 days from the date of notice. (Ord. 92-03, passed 5-20-92; Ord. 2008-13, passed 8-6-2008; Ord. 2017-07, passed 5-22-2017)

**§ 93.22 RECONSIDERATION OF ASSIGNMENT OF ROAD NAME.**

(A) Affected property owner(s) or occupant(s), and appropriate public, and semi-public agencies shall have a right to request a reconsideration of the assignment of a road name.

(B) Such reconsideration requests shall be made to the Board on appropriate forms, and according to procedures below in this section.

(C) All road name reconsiderations shall be accompanied by an appropriate fee, in an amount

established by order of the Board of Commissioners, and shall state the reason(s) for the reconsideration and alleged error(s) made.

(D) Affected property owner(s) or occupant(s), and appropriate public, and semi-public agencies shall have 30 days from the date of the road name assignment in which to file a reconsideration request.

(E) A reconsideration request shall be limited to whether the criteria in this chapter was correctly applied to a road name assignment.

(F) All reconsiderations shall be on a de novo basis where the body reviewing the reconsideration shall be able to receive any additional testimony presented by the applicant(s) or proponent(s).

(G) No application for a reconsideration shall be permitted by the Board within one year of denial of such reconsideration request, unless in the opinion of the Board new evidence or change of circumstances warrant it.

(H) A road name reassignment becomes final when no further right of reconsideration is possible. Within 10 days of the road name reassignment the Board shall sign an order establishing the road name as officially adopted.

(I) Affected property owner(s) or occupant(s) shall have 60 days from the date of the Board order of road name assignment to begin using the road name with their new address.

**§ 93.23 NOTICE OF DECISION.**

Following the assignment of a road name by the Planning Department, or from an order of the Board, the Planning Department shall:

(A) Notify the applicant(s) requesting the road name of the action;

(B) Send copies of the assigned road name to the appropriate entities listed in § 93.21(C);

(C) File the Planning Department assigned name or a Board order naming the road with County Records;

(D) A copy of the assigned name or a Board order name shall be kept with the Planning Department.

**§ 93.24 ROAD NAME POSTING.**

Road name signs shall be installed according to County Road Department standards and other appropriate safety considerations. No private road name signs shall be independently installed without approval by the County.

***ADDRESS SYSTEM***

**§ 93.40 METHOD OF ADDRESSING.**

(A) The county address system is established by this chapter as the official address system for the unincorporated portions of the county. All qualifying areas of the county shall be renumbered in such a manner that the address of a residence, business, or other building requiring an address, will be a five digit number taken from the Oregon State Coordinate System with appropriate alterations to meet local needs for a uniform numbering system.

(B) Existing homes, buildings, and businesses shall be numbered on a postal delivery area basis. New addresses issued under the provision of this chapter shall not be assigned on an individual or piecemeal basis outside the postal delivery area being comprehensively readdressed.

(C) Buildings accessed from roads predominantly extending north-south will have a five digit number derived from the north-south axis, or y-axis, of the State Coordinate System. The last digit from the SCS y-axis numbers shall be disregarded. Numbers for buildings essentially west of a road shall end in an even number and numbers for buildings east of a road shall end in an odd number.

(D) Buildings accessed from roads predominantly extending east-west will have a five digit number derived from the east-west axis, or x-axis of the State

Coordinate System. The first and last digit from the SCS x-axis numbers shall be disregarded. Numbers for buildings essentially south of a road shall end in an even number and numbers for buildings north of a road shall end in an odd number.

(E) Address numbers are estimated from an overlay of the State Coordinate System onto field sheets based on the intersection location of the building access road and named road, lane, drive, loop, or highway. The State Plane Coordinate System is used to determine a point of reference on a road. All buildings along the road are then assigned addresses based on the distance (following the road) from this reference point to a driveway or entrance.

(F) Apartment houses, mobile home parks, and other multi-unit dwellings shall be addressed with one main address. Individual units within these complexes shall be assigned an address identifier in a uniform and understandable manner. Interior addresses shall be jointly developed by both the management/owner(s) and Planning Department. Final approval shall be acceptable to the Planning Department.

(G) If deemed appropriate, business complexes where there are several businesses within the same building shall have individual addresses for each business. Businesses associated with dwellings shall have individual addresses if conducted from a separate building.

#### **§ 93.41 RESPONSIBILITY.**

The Planning Department shall have the responsibility for assigning rural addresses.

#### **§ 93.42 ADDRESSING.**

Once a postal delivery area has been officially assigned addresses, new buildings and replacement or relocation of existing buildings with new primary driveways within that postal delivery area shall be assigned addresses in accordance with provisions herein after provided.

(A) The Planning Department shall assign a new address when a zoning permit for a new or relocated building is applied for and issued.

(B) If access to the property is off a County Road or State Highway, a new address will be issued by the Planning Department only after the appropriate jurisdiction has issued a road access permit.

(C) Assignment of the address will be done in accordance with § 93.40(C)-(F) of this chapter.

(D) The applicant for a zoning permit will provide the location of the main access point of their driveway from a road, lane, highway, or other road designation that may apply.

(E) A supplemental fee approved by the Board will be charged to cover the cost of providing the address number post and installation.

(F) Damage resulting in an address being unreadable or the removal of said address post will require its replacement. Cost of a replaced address post will be the applicant(s)/owner(s) responsibility.

(G) The Planning Department will notify the appropriate postal service area and appropriate agencies in §93.19(B) of all new addresses issued pursuant to this section.

#### **§ 93.43 CHANGING ADDRESS NUMBERS.**

The following procedures and standards shall apply when changing address numbers initially adopted under the provisions of this chapter:

(A) Changing an existing address may be initiated by the Planning Department, or by application by the property owner, or any public agency that may be affected by the address number.

(B) All changes in address numbers shall conform to the address system and the standards for address numbers set forth in § 93.40 of this chapter.

(C) An existing address number may be changed by the Planning Department if it is not in conformance

with the address system. Proposed address number changes shall be made pursuant to procedures set forth in divisions (D) through (I) of this section.

(D) An application to change an address number shall be made to the Planning Department and shall include, at a minimum, the following:

- (1) Name of applicant(s);
- (2) Location of building;
- (3) Location of driveway;
- (4) Existing address number;
- (5) Reason for address number change;
- (6) Fee, as may be established by the Board.

(E) The Planning Department shall evaluate any proposed change to determine whether it conforms to the standards set forth in § 93.40. If it does not, the application shall be denied. If the Planning Department determines that the application is consistent with the standards of this chapter, it shall proceed with the procedures set out in divisions (F) through (I) of this section.

(F) Notice of proposed address number change shall be provided to the property owner(s) and or occupant(s). The notice shall inform the property owner(s) and or occupant(s) of the county's intent to change the subject address 30 days from the notice and the reason for the change. The property owner(s)/occupant(s) shall be given 30 days from the date of the notice to comment in writing on the proposal.

(G) The proposed address change shall become effective 30 days from the date of the notice provided for in division (F) of this section, unless the Planning Department determines from the comments received in response to the notice provided under division (F), that the proposed change does not conform to the standards set forth herein.

(H) Within 10 days of receipt of timely comments, notice shall be sent to commenting owner(s) or occupant(s) informing them of whether the proposed address number change was corrected in response to

their comments. In cases where proposed address number changes are corrected in response to comments, the corrected address number shall become effective as of the effective date proposed in the original notice of proposed address change.

(I) The Planning Department shall notify the offices of County Records, County Assessor, Public Works Department, Postmasters, and any affected Public Safety Departments of a change of address number within 30 days of the date the new number becomes effective.

**§ 93.44 DISPLAY OF ADDRESS NUMBERS.**

(A) All buildings requiring addresses located in areas where this chapter applies shall display an address number in a manner approved by the Planning Department.

(B) The address and address post must be clearly visible from the main road, lane, highway or other applicable road designation from which the address assignment is based.

(C) Numbers and address posts shall be of a type determined by the county.

(D) Additional displays of an address number may be permitted at owner(s) or occupant(s) expense. These additional displays shall not visually interfere with the officially assigned address and shall be the same number as the officially assigned address.

(E) Address numbers and address posts shall be obtained from the county if available.

***SCENIC-HISTORIC ROADS***

**§ 93.60 PURPOSE.**

The purpose of this subchapter is to create a “Scenic-Historic Road” system in the county in order to direct and expose residents and tourists to the scenery



and history of the county in fulfillment of needs for educations, recreation, and tourism.  
(Ord. 87-5, passed 5-28-87)

### § 93.61 CRITERIA.

The following general criteria are hereby established to assist in determining the eligibility of a particular road or road segment as a “Scenic-Historic Road:”

(A) The road shall pass through or by, or lead to, scenic area and/or historical sites of local, state, or national interest.

(B) The roadway shall be improved gravel or pavement, to insure relative ease of travel. The road need not be high speed, and indeed a winding “country road” is preferable.

(C) The road shall be either a through road or shall have a convenient turn-around at the end. The latter road type is acceptable in recognition of the many scenic and historic routes leading up canyons in the foothills of the Blue Mountains.

(D) The road shall be a dedicated county road, or also a city street, state or federal road or highway, if a city, the state, or the Umatilla National Forest agrees to participate in the Scenic-Historic Road designation and marking program.

### § 93.62 ESTABLISHING A SCENIC-HISTORIC ROAD.

The following procedures shall be used in establishing a “Scenic-Historic Road:”

(A) *Nomination.* A road or road segment may be nominated as a “Scenic-Historic Road” by any of the following methods: petition by citizens, written request by a city or citizen's group, or at the initiative of the county itself. Nominations are to be directed to the Board of Commissioners and shall contain the following information: a map of the proposed route, a brief description of the historic and scenic attributes of the route, and the reason for the nomination.

(B) *Review of a nomination.* Once a nomination has been received at the County Courthouse, the following steps shall be taken to review a nomination:

(1) The Board of Commissioners will forward copies of a nomination request to the County Road Department and County Planning Department within one week.

(2) The County Road Department and County Planning Department will then prepare a report on the road or road segment proposed for designation and report back to the Board of Commissioners within one month. Their report shall include the following: an accurate map of the proposed route, a description of the scenery to be observed along the route, an identification of the historic sites to be found along the route, an inventory of the roadway conditions, a set of color slides illustrating the scenic and historic sites along the route, a discussion of the value of the particular route as a “Scenic-Historic Road,” a discussion of any problems that might arise with regard to official designation, and a recommendation in favor or against designation.

(3) The Board of Commissioners will schedule and advertise a public hearing and informational meeting regarding the proposed “Scenic-Historic Road,” utilizing the standards and procedures for a public hearing as set forth in the County Development Code (Chapter 152). In addition, a press release describing the proposed “Scenic-Historic Road” and the county departments' recommendations will be prepared and sent out two weeks in advance of the hearing to the press, and to all affected cities, state and local agencies, citizen's groups, and key property owners. Notices will also be posted at intervals not to exceed two miles along the proposed route, at least two weeks in advance of the hearing.

(4) At or following the public hearing, the Board of Commissioners will decide whether or not to designate the proposed route as a “Umatilla County Scenic-Historic Road.” Written notice of their decision will be provided to all interested parties. The official designation shall be in the form of a resolution.

### § 93.63 MARKING AND MAINTENANCE OF SCENIC-HISTORIC ROADS.

(A) Marking and maintenance of scenic-historic roads shall be a public/private partnership between the County Road Department, cooperating citizen's groups, and a city, the state, or the Umatilla National Forest.

(B) The County Road Department will continue maintenance responsibility on dedicated county roads only, and the degree of maintenance shall only be that which is normally given the road or that which is necessary to maintain easy travel during the spring, summer, and fall months, if so authorized by the Board of Commissioners.

(C) A city, the State Highway Division, or the Umatilla National Forest shall be solely responsible for maintaining those portions of a scenic-historic road that are city streets or state or federal roads and highways, if these jurisdictions agree to inclusion of their facilities as a scenic-historic road.

(D) Marking of scenic-historic roads on dedicated county roads shall be the financial responsibility of citizen's groups, with the cooperation and assistance of the County Road and Planning Departments, as necessary. Marking shall include both signage and advertising in the form of brochures, maps, etc. All signage shall be of a standardized agreed to by the County Road Department, and as necessary, the State Highway Division.

(E) Signage shall include the following:

(1) Identification signs along each scenic-historic road.

(2) Directional signs leading to each scenic-historic road, from nearby cities, interstate freeways, state highways, and major county roads.

(3) Identification signs for historic sites along each scenic-historic road.

(4) Interpretive as needed and available.
