#### Part 1- Explanation and Information

EURUS COMMUNITY BENEFIT PLAN is an entity chartered by the Umatilla County Board of Commissioners to distribute funds donated by the Plan Sponsor, Eurus Energy America Corporation. This is the company that owns and operates the Combine Hills Turbine Ranch I and II wind power project.

The EURUS COMMUNITY BENEFIT PLAN is less formal, but operates similarly to a foundation. It is administered by a 4 person board. Available funds are periodically distributed pursuant to a grant application process. Prefer to combine with other funding sources.

The following types of organizations situated <u>within the geographical boundaries</u> of the Milton-Freewater School District are eligible to apply: social, charitable, fraternal, public, educational, and developmental and other entities (or individuals) that sponsor projects and activities that create or enhance community interests.

Criteria for awards will include these: the amount requested (up to \$5,000.00 is allowed); the uniqueness and character of the project; project readiness and ability to complete (up to 12 months is allowed); project funding contributed or leveraged; nature and scope of public benefit from the project; operational expenses excluded, must be a permanent/structural type project.

A portion of available funds is dedicated to promote American-Japanese relations and exchanges, with emphasis on youth or business cooperation. An award of or from these funds is not subject to the geographical limits that otherwise apply.
