

DESCRIPTION OF RECORD:

RECORD DESCRIPTION NORTHERN PACIFIC RAILWAY COMPANY TO EL PASO GAS COMPANY, EASEMENT DEED 26058-W RECORDED IN BOOK 264 OF DEEDS AT PAGE 488, DOCUMENT NO. 239675, UMATILLA COUNTY, OREON, AUGUST 30, 1961.

THE 50-FOOT BY 100-FOOT TRACT OF LAND FOR MEASURING AND REGULATING SITE IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:
