
THE BOUNDARIES OF THE ORIGINAL RESERVATION ADDITION LOTS AND BLOCKS WERE ESTABLISHED USING THE ORIGINAL ANGLES AND DISTANCES ESTABLISHED PER THAT PLAT, ROTATED TO THE BASIS OF BEARINGS FOR THIS PLAT.
