Corner originally set by Daniel Chaplin under contract No. 107 Dated September 21, 1864. His record reads: Set post for 1/4 section corner in mound of earth with charred stake, pits, etc., as per instructions. Zenas F. Moody under contract No. 164, dated October 4, 1871, stated: Set post. Currin and Noland under special contract dated May 4, 1887, stated: Set stone, 7 x 8 x 10. In record of survey H-254-B, found stone, set witness monument.

Monument and Accessories found: ( condition and source )

I found a 3" brass capped witness monument from the Reclamation survey H-254-B 30 feet west of the true corner. At the true corner I found a basalt stone 11x8x6 ins. with a "4" and with a a possible "x" on top. There was a railroad spike in a coil of baling wire on the east side of the stone and a 3/8"x8" nail set over the spike. A 1/2" iron rebar (origin unknown) bears N60°19'18"E 3.70 feet:



MONUMENT (S) AND ACCESSORIES SET (Procedures and Description) At the true corner point I set a 1 1/4" x 30" Galvanized Iron Pipe with a 2 1/2" brass cap stamped as shown in the diagram above. The cap is 6" below the surface of the road. I buried the stone along side.

For references, I set three 5/8" by 24" iron rebars with 1 1/4" orange plastic caps stamped WTS and 56295LS as described below:

an iron rebar bears N35°32'41"E, 33.90 feet under the existing fence; an iron rebar bears S29°25'57"E, 32.05 feet under the existing fence: an iron rebar bears N89°53'27"W, 61.34 feet under the existing fence; the brass cap (Refuge Monument No. 7) bears N89°34'33"W, 30.00 feet;

The monument and references were tied using a Trimble R7/R8 RTK GPS system.
