Set a basalt stone 10x8x6 ins. marked 1/4 on west face and raised earth mound along side. Lincoln Wilkes in his 1917 resurvey states: found basalt stone 10x10x8, not marked and pits visible. Set an iron post 3 ft. long and 1" diam. for witness cor. to the 1/4 sec. cor. with brass cap.

MONUMENT (S) AND ACCESSORIES SET (Procedures and Description) At the proportionate point I set a 1 1/2" x 30" galvanized iron pipe with a 2 1/2" brass cap stamped as shown in the diagram above. The cap is 24" below the surface.

For references I set three 5/8"x24" iron rebars with 1 1/4" orange plastic caps stamped WTS and 56295LS as follows:
