Record states: Set post, 4 1/2 ft. long, 4 ins. sq., 2 ft. in ground, on steep hillside, facing E. and 300 ft. above bottom of canyon and 400 ft. below summit, for Cor. to Tps. 1 & 2 S., R.34 and 35 E., marked: T.1S.,S.31 on N.E., R.35 E., S.6 on S.E., T.2 S., S.1 on S.W., R.34 E., S.36 on N.W. faces, with 6 notches on E. edge, from which, A pine, 8 ins. diam., brs. N.26° E., 112 lks. dist., marked T.1S., R.35 E.,S.31, B.T. No other tree in limits, raised mound of stone alongside. Corner recovered and remonumented by Lincoln E. Wilks under special instructions dated Feb. 20, 1917. Group 29. Record states: Intersect the point for Cor. of Tps. 1 & 2S., Rs. 34 & 35 as determined by reference to the N.E. bearing tree. This point is on a steep E. slope, where it is impracticable to set an iron post, more than 6 ins. in ground; therefore, at a point 30 lks. W. of true Cor. point Set an iron post, 3 ft. long, 3 ins. diam., 24 ins. in ground, for witness Cor. to Tps. 1 & 2 S., Rs. 1 & 2 S., Rs. 34 & 35 R.

and raise mound of stone, 2 ft. base, 1 1/2 ft. high, S. of post. From the true Cor. point a pine bears N 26° E, 112 lks marked T.1S., R.35E., S.31,B.T. (Old B.T.) A fir, 12 ins. diam., brs. S.17°45'W., 352 lks. dist., marked T.2S., R.34E., S.1, B.T. (New B.T.)

MONUMENT AND ACCESSORIES FOUND:

Found 3 1/2" brass cap on a 3" pipe 12" protruding 12" above ground level. A small mound of earth is supporting the monument. There is a small mound of stone South of the Witness Monument. Cap is marked as shown in monument marking detail. From which:

A 18" ponderosa pine with mostly healed blaze, which was opened to expose scribing. Tree bears N 43° E, 86.2 feet from witness corner monument.

Wilkes Fir bearing tree was not observed. There are several dead down firs in the vicinity of the tree location.

A 5/8" x 30" iron rebar with yellow plastic cap bears N 36°E, 43.8 feet.

A 5/8" x 30" iron rebar with yellow plastic cap bears N 45°W, 37.0 feet.

A 5/8" x 30" iron rebar with yellow plastic cap bears S 36° W, 39.5 feet.

A 5/8" x 30" iron rebar with yellow plastic cap bears S 32° E, 42. 7 feet.

Attached bearing object signs to all 5/8" iron rebars. Wired "witness" sign to the witness corner monument. All rebar accessories reference the witness corner monument.
