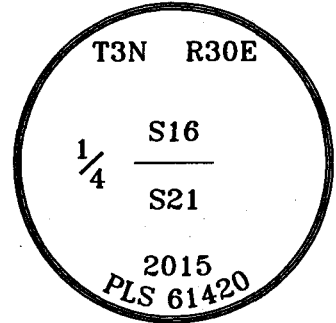

- SET 5/8" REBAR & CAP PLS 61420 1' BELOW GRADE, N65°47'E 33.76', ON ROAD BANK.
- SET 5/8" REBAR & CAP PLS 61420 1' BELOW BOTTOM OF DITCH, S53°10'E 23.70'.
- SET 5/8" REBAR & CAP PLS 61420 AT GRADE, S36°17'W 18.86', ON ROAD BANK, BEARING OBJECT SIGN ON GREEN STEEL POST.
- SET 5/8" REBAR & CAP PLS 61420 AT GRADE, N88°56'W 367.48', AT SOUTH EDGE OF MILE MARKER SIGN, BEARING OBJECT SIGN ON GREEN STEEL POST.
