PREVIOUS RENEWALS/SURVEYS ETC.: Corner originally established by D.S. Payne, under Contract No. 100, dated August 1, 1861. Record states: Set charred stake with mound, trench and pits as per insts. for corner to Secs. 24 & 25, T. 3 N., R. 31 E. & Secs. 19 & 30, T. 3 N., R. 32 E. Hayes, in undated survey No. Q-521-C, calls for a unmarked stone found. Hayes survey indicates a 1 inch pipe was set for the corner.

MONUMENT AND ACCESSORIES FOUND: None. We did find bits of fence wire, below ground, when searching for this corner.

MONUMENT SET:

Established corner position 3963.3 feet South of the recovered 1 inch iron pipe established for the North 1/16th corner common to Section 24 and 19, per Hayes Survey No. Q-521-C (undated). For alignment South of the 1 inch iron pipe, held the record calculated angle of 66°23'46" to the right, when occupying the 1 inch iron pipe and back sighting the recovered fence corner near the center 1/4 corner of Section 19, T3N., R32E., W.M. The stone and iron pipe reported on Survey No. Q-521-C was not recovered. We made an extensive search for the monuments reported for Section 19 on Survey No. Q-521-C and found only the 1 inch pipe for the N 1/16th corner common to Section 24 and 19, the old fence corner near the center 1/4 of Section 19 and an uprooted 1 inch pipe near the South 1/16th corner common to Section 13 and 18. At reestablished corner position, set a 2 3/8" brass cap on 1 1/4" x 30" galvanized iron pipe with top 15" below ground level. Monument marked as shown in monument marking detail. From which:

A silver Deep-1 magnet buried 24" below ground level bears North 53 1/2° East, 37.0 feet. A blue Deep-1 magnet buried 24" below ground level bears South 43° East, 39.9 feet. A purple Deep-1 magnet buried 24" below ground level bears South 39° West, 32.1 feet. An orange Deep-1 magnet buried 24" below ground level bears North 29° West, 34.1 feet. Set steel fence post with witness sign attached 1 foot North of monument. Buried bearing object signs with all magnets.

LOCATION AND COMMENTS: Corner is located in a North-South field line in a farmed area. No other features nearby.
