MONUMENT SET:

Re-established corner using indexed Oregon State Highway Department freeway map coordinates, after indexing State coordinates to our State Plane measurement values at freeway centerline monuments at 930+94.45 and 985+59.60. At reestablished corner position, set a 2" brass disk in concrete flush with asphalt pavement. Disk marked as shown in monument marking detail.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in a wood guard rail post bears North 46° East, 34.3 feet.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in a wood guard rail post bears South 45° East, 34.1 feet.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in a wood guard rail post bears South 33° West, 31.7 feet.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in a wood guard rail post bears North 22 1/2° West, 31.1 feet.

The most Southeasterly bolt with nut of metal bridge deck guard rail bears North 10° West, 64.9 feet.

The most Southwesterly bolt with nut of metal bridge deck guard rail bears North 24 $1/2^{\circ}$ East, 53.0 feet.

Attached bearing object signs to wood guard rail posts by brass washers.
