PREVIOUS RENEWAL/SURVEYS ETC.

This corner was originally established by D.S. Payne under contract no. 100, dated August 1, 1861. Record states: Set charred stake with mound, trench & pits as per insts. for 1/4 section corner.

Corner was re-established by William R. Wells with subsequent Monumentation record dated: 04/04/06. Record states "At reestablished corner position, set a 2 3/8" brass cap on 1 1/4" by 30" galvanized iron pipe with cap 12" below gravel road surface."

MONUMENT AND ACCESSORIES FOUND:

Prior to road construction, found and tied brass cap. Cap was undisturbed and as described in prior Monumentation record. After road construction, a search was made for the monument and only the flanges of the pipe were found. Also, all of the accessories set at the same time of Wells re-establishment of the corner were found undisturbed and are listed below.

MONUMENTS SET:

At the position of the re-established corner I set a 1" I.D. by 30" galvanized iron pipe with 2 1/2 " brass cap buried 12" below roadway surface, marked as shown for the East 1/4 Section 33. From which:

An existing 5/8" x 24" iron rebar with 1 1/4" red plastic cap marked "OR PLS 1106 WA PLS 17372" bears North 12° West, 60.5 feet.

An existing 5/8" x 24" iron rebar with 1 1/4" red plastic cap marked "OR PLS 1106 WA PLS 17372" bears North 41° West, 25.9 feet.

An existing 5/8" x 24" iron rebar with 1 1/4" red plastic cap marked "OR PLS 1106 WA PLS 17372" bears South 49 1/2° West, 23.4 feet.

An existing 5/8" x 24" iron rebar with 1 1/4" red plastic cap marked "OR PLS 1106 WA PLS 17372" bears South 19 1/2° West, 59.0 feet

LOCATION AND COMMENTS: Corner is located in the westerly side of the gravel road where the re-aligned Barnhart road joins the old Barnhart road.
