MONUMENT SET (PROCEDURES AND DESCRIPTION)

The 1 1/2" Iron pipe which has been used by all surveyors since at least 1963 is apparently too far South. Proportionally, it should lie about 32 feet North. I held the Eastings and set a 2 3/8" Brass Cap on 1" x 30" Iron pipe 0.6 ft. below surface of gravel driveway on the centerline of Minnehaha Road, as it was surveyed by John Kimbrell in 1907. (17 feet North of the 1 1/2" Iron pipe.) See my County Survey #1991-2.
