The Surveyor General records state: Set a Tamarack post on a N.W. face of a spur for 1/4 Sec.Cor. from which: A tamarack 5" ins. diam. brs. N 85° W, 58 lks.dist. A tamarack 14" ins. diam. brs. S 72° W, 92 lks.dist.

Monument(s) & Accessories Found: (Condition and Source)

Found remains of bottom of a blaze with axe marks in a rotted tamarack stump mound bear N 85° W, 38.3 feet (58 lks). A stump hole and remains of a rotted log bears S 72°W, 60.7 feet (92 lks) from re-established corner position.

Monument Set (Procedures and Description): At position established by reversed record bearing and distance from the recovered Section 16 bearing tree (S 85° E 38.3 ft.), set a 2 1/2" brass cap on a 1 1/2" x 30" galvanized iron pipe 25" in the ground with a surrounding earth and stone mound.

## New Accessories:

A 23" Douglas fir bears N 79°W, 11.1 ft. and is scribed 1/4 S9 BT. A 20" Douglas fir bears N 14  $1/2^{\circ}$ W, 6.8 ft. and is scribed 1/4 S9 BT. A 23" Douglas fir bears S 67°E, 35.2 ft. and is scribed 1/4 S16 BT. A 20" western larch bears S 33°W, 41.8 ft. and is scribed 1/4 S16 BT. All bearing trees have blaze and a six inch red band painted around them. Nailed a brass washer stamped PLS 1106 and a bearing object and witness sign to each tree. Set a steel fence post 3 feet North of monument with witness corner sign attached.

Location & Comments: Corner is located on a North facing ridge approximately 100+/- from top of spur. Corner falls in dense underbrush.
