Previous Renewals/Surveys, etc.: This corner was originally set by U.S. Deputy surveyors, Charles L. and William C. Campbell, under Contract No. 733. Dated March 22, 1901. The Surveyor Generals notes state: "Set and ironstone 28 x 15 x 10 ins. 21 ins. In the ground for ¼ sec. cor., marked ¼ on the N. face, raised mound of stone 4 ft. base, 3 ft. high N. of cor., pits impracticable.

Monument(s) & Accessories Found (Condition & Source): Found a basalt stone 25" x 15" x 10", with a faint ¼ chiseled on the exposed side, partially buried on a steep West facing slope, per the original survey. No evidence of the rock mound remains, the hillside appears to have been subject to substantial erosion.

Monument Set (Procedures & Description): At the location of the found stone set a 1 ½" x 30" galvanized iron pipe with a 2 ½" brass cap marked as noted, 6" in the ground, struck rock. Erected a stone mound 4' in diameter 2' high around the monument.

New Accessories: A steel fence post with a land survey monument sign was placed 2.5' East of the corner. 5/8" x 30" rebar reference monuments with a yellow plastic cap stamped "TOMKINS SURVEYING" attached were set 28" in the ground, a steel fence post with a Umatilla County Bearing Object sign attached were set alongside each R.M. The reference monuments (R.M.) bear from the corners as follows:

Location & Comments: The corner falls on a steep west facing slope 1000'± North and 900' higher than the South Fork of the Walla Walla River.
