Found no evidence of original stone mound.

Monument Set (Procedures and Description): Bed rock is 6-8" below the surface. I chiseled a hole in the rock 2" wide x 6" long, 4"deep, and set a railroad spike, head down in the crack and secured it with concrete patch, a 1" aluminum cap marked as indicated in the monument detail is firmly attached, and built a stone mound around it. New Accessories:

A rock out cropping X BO with a P.K. nail in it 2' N. of the end and 4' above

ground brs. S.57°E., 47.7 ft. A 5/8" x 30" rebar with a plastic cap stamped WE WELLS PLS 1107, set 12" in the ground with a mound of stone to the top brs. S.45°W., 23.6 ft.

A large rock outcropping X BO with a P.K. nail in it 6' above ground and 10' S. of the crest of the spur brs. N.57°W., 127.1 ft.

A 5/8" x 30" rebar with a plastic cap stamped WR WELLS PLS 1106, set 8" in the ground with a mound of stones to the top brs. N.4°E., 37.1 ft.
