After much search and tying to many corners in the area, I determined there was a large error made between the $\frac{1}{2}$ cor. common to Sections 28 & 29 being 2.73 chains longer than the original GLO calls. At this location I found the following evidence for this section corner as was described in the survey made by George S. Pershin during 1879: A tamarack stump with BT scribed on its face bearing N 57 E, 67 lks. dist. from assumed corner location.

A fir stump with BT scribed on its face bearing S 70 W, 28 lks. dist. from assumed corner location.

A fir stump with BT scribed on its face bearing N 44 W, 62 lks. dist. from assumed corner location.
