MONUMENT MARKING DETAIL:

T5N R33E 1/4 <u>S13</u> S24 2010 PLS 1106

MONUMENT SET: Held intersection of centerline of Duroc County Road with old field berm extending south and north as best remaining evidence of the original corner location. Set a 2-3/8" diameter brass cap on a 1 1/4" x 30" galvanized iron pipe, with top of brass cap 6" below gravel road surface and stamped as shown in "Monument Marking Detail".

New accessories:

A 5/8" by 24" rebar with 1 1/4" red plastic cap bears N  $62^{\circ}$  E, 32.2 feet. A 5/8" by 24" rebar with 1 1/4" red plastic cap bears S  $03^{\circ}$  W, 15.2 feet. A 5/8" by 24" rebar with 1 1/4" red plastic cap bears S 78° W, 58.9 feet. A 5/8" by 24" rebar with 1 1/4" red plastic cap bears N  $61^{\circ}$  W, 48.9 feet.

Nailed a "witness" sign to a rail road tie post at south edge of road.

Red plastic caps on rebar accessories are marked "OR PLS 1106 WA PLS 17372". The rebar accessories are set near road shoulder. Wired a bearing object sign to each of the rebar accessories.

LOCATION AND COMMENTS: Corner is located at a point in the centerline of Duroc Road and a farmed field berm to the south and a fainter field berm to the north. A steel tape and magnetic compass were used to measure bearings and distances to accessories.
