Corner was originally established by Odell & Lewis, under GLO Contract No. 110, dated February 7, 1865. Notes state: Set post Cor. for Secs. 25, 36, 30 & 31, on side hill facing the E.; drove charred stake, dug pits and raised mounds as per instructions.

In record of Private Surveys, Survey No. 78, J.W. Kimbrell held the intersection of a sod fence running West 1/2 mile and North 1 mile and monumented with a stone  $14 \times 8 \times 7$ .

Record of Survey No. 03-314-C found and held a railroad tie fence post for corner point.

## MONUMENT AND ACCESSORIES FOUND:

Found railroad tie fence post with field line extending North and West as per Survey No. 03-314-C.

MONUMENT SET: I held the railroad tie post at intersection of field lines North and West as best remaining evidence of the original corner location. At the South side of the railroad tie post, set 2 1/2" brass cap on a 2 1/2" x 30" galvanized iron pipe, 30" in the ground, marked as shown in Monument Marking Detail.

New accessories:

A silver deep-1 magnet buried 20" below ground level, bears North 46° East, 49.9 feet. A purple deep-1 magnet buried 20" below ground level, bears South 50° East, 55.2 feet. A blue deep-1 magnet buried 20" below ground level, bears South 30° West, 54.2 feet. An orange deep-1 magnet buried 20" below ground level, bears North 48° West, 55.6 feet. Buried bearing object signs with deep-1 magnets. Nailed "witness" sign to railroad tie North of corner monument.
