A White Fir 20" in diameter with a BT tag saying corner was S8°E 10.0 ft.

Tree had been blazed about 1956 and had visible scribing "S31". Tag says that he set a stone in 1956 bearing and distance from an original NE BT. Then a decaying stump with visible scribing "BT". Found stump hole that matched bearing and distance to original NE BT but no evidence of scribing. Could find no evidence of 1956 stone.
