Found original Northeast bearing tree and BLM bearing trees as described in the BLM record above. Blazes on BLM trees have healed over. (Did not identify original Northwest bearing tree)

Distances to existing BTs are to the center of the tree

Description of monument and accessories I established to perpetuate the original location of this corner:

Painted a 6 inch red band around all BTs and attached bearing tree and land survey monument signs, except original Northwest bearing tree stump, which was not identified.

Set a steel fencepost approximately 5 feet North with land survey monument and property boundary sign attached.
