Corner original comer establishment: Corner originally established by Frank W. Campbell under GLO contract number 468, dated 1883. Surveyor General record states: Set basalt stone 15x12x8 ins 8 ins in ground for cor to secs 25, 26,35&36 marked with 1 notch on S& edges from which: A pine 20 ins dia brs S18°E 102 lks. dist. marked T5S R30E S36 BT A pine 10 ins dia brs S18°E 102 lks. dist. marked T5S R30E S26 BT A pine 30 ins dia brs N64°W 69 lks. dist. marked T5S R30E S26 BT Corner remonumented by BLM in 1978. BLM notes state: The cor of secs 25,26,35 and 36, monumented with the original unmarked basalt stone, 15x12x8 ins, firmly set 2 ins in the ground and in a mound of stone from which the original bearing trees: A pine 26 ins diam bears N70°E, 67 lks dist with scribes visible on open blaze. A pine 26 ins diam bears S18°E 104 lks dist with scribes visible on open blaze. A root hole bears N64°W 69 lks dist with a down and decayed pine alongside, no marks visible. At the corner point: Set an iron post 28 ins long 2½ ins diam 15 ins in the ground and in a mound of stone 3 ft. base to top with brass cap marked (shown below) from which a new bearing tree: A pine 14 ins diam bears N55°W, 34 lks dist mkd T5S R30E S26 BT. Deposit corner stone alongside iron post\_No record of subsequent monumentation found in Umatilla County survey records.
