Previous Renewals/Surveys, etc.: This corner was originally set by U.S. Deputy Surveyors William Odell and William Lewis under their contract No. 110 dated February 7. 1865. The Surveyor Generals notes state "set post corner, drove charred stake, dug pits and raised mounds per instructions". A survey by Bradley dated November 27, 1910, corrected plat made June 17, 1911, shows a rock with an "x". As shown on County Survey No. 00-31-C, dated February 23, 2000, Paul Tomkins set a 1" x 30" galvanized iron pipe with a 2 ½" brass cap by double proportion.

## Monument(s) & Accessories Found (Condition & Source):

In the SW corner of Section 22, T6N R34E, found 1" galvanized iron pipe with 2 ½" brass cap 5" below the surface of the Alfalfa Field.
