Previous Renewals / Surveys, etc.

Corner originally set by Deputy Surveyors Odell & Lewis under contract No. 110 dated February 7th, 1865. Their record reads: Set post Cor. for Secs. 29, 30, 31, & 32. Land slopes to N.W. Drove charred stake; dug pits & raised mound, as per instructions. Willard Bradley under survey Q-813-A, 1914, states "Stone established". Aubrey Perry under the survey recorded in Book 2 Page 306 of the record of private surveys, 1919, indicates he did not find Bradley's stone.

Monument and Accessories found: (condition and source) None: The position falls in a plowed field.



MONUMENT (S) AND ACCESSORIES SET (Procedures and Description)

I set a 11/2" x 30" galvanized iron pipe with a 2 1/4" brass cap stamped as shown in the diagram above 20 inches below the surface at the position calculated from Aubrey Perry's record based on his found monuments at the Northwest corner, North 1/4 corner and West 1/4 corner of Section 30.

For references, I set four, 5/8" by 24" rebars with 1.25" orange plastic caps attached, stamped WTS and 56295LS as described below:

an iron rebar bears N73°42'52"E, 119.57 feet under the existing fence;

an iron rebar bears S68°51'40"E, 120.42 feet under the existing fence;

an iron rebar bears N49°16'40"W, 21.20 feet 20 inches below the surface in the plowed field; an iron rebar bears S78°17'12"W, 150.99 feet with a collar of stone on the south side of a field road

The monument and references were tied using a LIECA system 300 RTK GPS.
